## 1. Cooperating NGO

Cooperating NGO is a non-profit organization whose objective is to carry out international cooperation projects, contributing to the comprehensive and sustainable development of communities in different developing countries.

To fulfil these objectives, the following activities are carried out:

1. Promotion of awareness regarding the diverse realities of various cultures through presentations, events, or access to the media.
2. Fundraising efforts in both the public and private sectors, including presentations for public subsidies or collaborations with private entities to secure the necessary resources for project implementation.
3. Technical assistance, execution and evaluation of projects directly or in collaboration with local entities from the various countries where work will be carried out.

### Mission and vision

- Mission: Foster well-being in developing countries by providing economic support to local social organizations for the implementation of sustainable projects in the fields of education and health.
- Vision: Realize empowered communities where all individuals experience complete equality and have equal opportunities.



## 2. Sponsors Cooperating NGO

The Cooperating NGO sponsorship program aims to offer quality education to children and young people in vulnerable situations. To achieve this, committed sponsors will be sought to contribute the necessary fees to cover a child's school expenses until they finish their formal education.

Being a Cooperating NGO sponsor means being part of the path that a child takes throughout their school years, knowing their academic performance, as well as their concerns and dreams.

However, being a Cooperating NGO sponsor also entails great responsibility. Behind every scholarship there is a child with the hope of going to school and the hope of finishing their studies and starting a professional career. This is why a very high level of commitment is required when it comes to being a sponsor.

Cooperating NGO aims to provide quality education enabling new generations to pursue meaningful employment and secure a decent future. To accomplish this objective, an assessment of schools and training centres is conducted, always selecting those most suitable for the well-being and education of each child.

### 2.1. Become a sponsor of Cooperating NGO

There are several ways to become a Cooperating NGO sponsor:

- **Through the website:** By completing the contact form indicating your desire to become a sponsor. Once we receive the request, we will contact you to give you all the details.

### 2.2. School fees

School fees are determined by the school, the course, and other specific needs of each child. For this reason, information regarding each child will be sent to his/her sponsor.



Payment of the fees is facilitated through direct debit to the Spanish account of the NGO. To initiate this process, sponsors are required to complete the sponsorship form provided along with the school fees. Sponsors have the flexibility to choose the payment frequency, whether monthly, quarterly, or annually.

The school year begins in January/February, and payments are scheduled as follows:

- Annual payment: January
- Quarterly payment: January – April – July – October.
- Monthly payment: every month from January to December.

School fees include 8% management fees.

### 2.3. Shared sponsorships

Cooperating NGO is committed to quality education. To guarantee this, a study has been carried out of the best schools in the area and the most appropriate ones have been selected for each project. This selection has been made jointly between the project directors and Cooperating NGO. Several factors have been taken into account, such as academic results, distance to the centre or price.

As a result, private schools have been selected, whose annual fees may be high for certain sponsors. For this reason, we offer the option of carrying out shared sponsorships, that is, sponsoring a child between two sponsors.

### 2.4. Responsibilities as a Cooperating NGO sponsor

Being a Cooperating NGO sponsor means having the following responsibilities:

- Pay the monthly, quarterly or annual instalments of the scholarship.

### 2.5. Benefits as a Cooperating NGO sponsor

Being a sponsor of Cooperating NGO means having the following benefits:

- Become a partner of Cooperating NGO.
- Receive academic reports at the end of each term.
- Receive a photo of the sponsored child at the end of each term.



## 2.6. Data modification

If any changes to the sponsor information are to be modified, an email must be sent to [info@cooperatingngo.com](mailto:info@cooperatingngo.com) indicating the changes to be made.

## 2.7. Cancel the sponsorship

Despite the commitment required to be a sponsor for Cooperating NGO, if a sponsor is unable to cover a child's school fees, they may request a cancellation. To initiate this process, please send an email to [info@cooperatingngo.com](mailto:info@cooperatingngo.com) expressing the desire to discontinue sponsorship. The request will be effective from the next school year, ensuring that children can complete the current academic course.
